**Subject: Museum Scenography Park - AMENDED AND INTEGRATED
Determination NR. 255 of 7/12/2012 having the object "CONDITIONS FOR ISSUE AND
DELIVERY OF CRACO DAILY CARD AND CRACO CRACO CARD GOLD"**

THE PERSON IN CHARGE OF SERVICE

Given that: The Council's meeting nr. 117 of 19/12/2011 conclude the condition of visit of the Museum Scenography Park of Craco and settled down the procedures its issuing and release of Craco Card Daily and the Craco Card Gold; - With the Council's deliberation n. 91 of 12/11/2012, and nr.95 of 27/11/2012, were established further operational guidelines about the terms and conditions of the visit in the aforesaid Museum Scenography Park; - with Council's deliberation nr.96 of 3/12/2012, was arranged for the use of the extension of the old path kept in safety and the Museum Park scenography, already established with Council's deliberation n. 27 of 4/4/2011;

- With its determination nr.255 of 7/12/2012, was arranged to regulate and coordinate the terms and conditions for visit of the Museum Scenography Park of Craco, through the Institute of Craco Card referred in Annex 1, the 'CONDITIONS FOR THE ISSUE AND DELIVERY OF CRACO CARD DAILY' and Annex 2 'CONDITIONS FOR THE ISSUE AND DELIVERY CRACO CARD GOLD'
- With the Ordinance n. 10 of 7/12/2012, and n.03 of 23/5/2015, the Mayor who in a person of Government Official and Authorities of the Civil Protection, as well as' Local Public Security, confirms the state of emergency and danger for public safety in the historic centre of Craco and in the neighbouring areas, except the secured pathway established by the abovementioned administrative measures;
- With the Council's deliberation nr.78 of 27/12/2015, were given new addresses for the conditions of the visit and its fruition of the museum Scenography Park;

Appeared necessary to adapt the rules, terms and conditions of the visit of the Museum Scenography Park of Craco as shown in the annex to this determination and precisely the Annex I as regards "CONDITIONS FOR THE ISSUE AND DELIVERY CRACO CARD DAILY" and Annex 2 as regards "CONDITIONS FOR THE ISSUE AND DELIVERY CRACO CARD GOLD" HAVING REGARD TO THE T.U.E.L. N or 267/2000;

Having regard to the decree of the trade union nr. 10 of 31/12/2009;

Determines

- L) to amend and supplement its determination nr.255 of 7/12/2012 in order to regulate and coordinate the terms and conditions of the visit of the Museum Scenography Park of Craco, through the Institute of Craco Card;
 - 2) To acknowledge that all the terms and conditions of visit to the Museum Scenography Park were coordinated and set out in the annexes to the present determination and precisely:
 - Annex 'CONDITIONS FOR THE ISSUE AND DELIVERY OF CRACO CARD DAILY'
 - Annex 2 'CONDITIONS FOR THE ISSUE AND DELIVERY OF CRACO CARD GOLD'
 - 3) To forward this determination with the relevant annex to the company of Craco Research Ltd. and communal group of civil protection;

CONDITIONS FOR ISSUE AND DELIVERY OF CRACO DAILY CARD

The municipality of Craco in relation to the urgent needs for regulation of the flow of visitors in the old town centre and surrounding areas for the purposes of the general objective of protecting and enhancing the monumental historic assets, archaeological and landscape in the municipal's territory, emits the present Craco Card and lays down the following conditions of its release; The valid Craco Card are those stamped and countersigned by the municipality of Craco:

1. The Craco Card Daily is an individual instrument of accession and voluntary support to the project of enhancement of the heritage monumental historical, archaeological and landscape of the municipal territory.
2. It is issued to all either residents and/or non-residents wishing to make a suggestive visit in our Secured pathway in the Museum Scenography Park of Craco, in places that are permitted and in compliance with the municipal ordinances.
For the residents of Craco it is applied a reduction of 50% on daily and in the evening rates, whiles under 14 to 18 years shall be applied a reduction of 70% if accompanied by an adult.
3. The visit includes the secured path areas of the historic town, the Media Centre. The Atelier of Art and Cinema, the monastery of the Franciscan Minor Friars and the Palace of Culture. Visit routes can be customized in the case of groups of at least 5 persons. The Craco daily card entitles you to an access and abidance in the delimited areas governed by the Ordinance for a maximum of one hour. In these areas would be available to visitors a helmets of the civil protection.
4. The Craco Card which has a day of validity entitles you to a discount of 30% on multimedia productions, on payable events and on other products which the municipality will promote.
5. At the Media Centre one is entitles to free access of internet and to the multimedia room in which you can view documents, archives of images and video on Craco.
6. Entitles you to a day free parking in parking areas allowed in the quarters of S. Angelo adjacent to the historic centre and those reserved to the holders of Craco Card.
7. Holders Craco Card are allowed to take photographs and amateur video for personal use only.
8. The minimum donations for the release of Craco Card is € 10,00 in case of day visit if only ones want to take the secured pathway of the historic centre and € 15,00 for complete visit. In case of groups, the donation can be adjusted with the Craco Card Gold valid only on the day of release.
9. The holders of Craco Card can be followed for free by minors under aged 14.
I. The evening and pre-evening visits in the illuminated secured pathway of the historic centre is carried out exclusively on the basis of reservation with a minimum of 3 visitors. The visit of groups consisting of 3 to 5 visitors will be adjusted using the CRACO CARD GOLD valid only on the day of release with a basic amount of € 100,00. For each additional visitor is established an additional cost of € 20 00.
- 1 1. Tours in English can be made with an addition of € 5,00.
12. Holders of Craco Card undertake to respect all the rules and regulations in the use of computer and telematics services. They're prohibited the photographic and audio-visual works for professional use. Those who intend to shoot for professional activities must first be authorised by the municipal administration.

CONDITIONS OF ISSUE AND DELIVERY OF CRACO-GOLD CARD

The municipality of CRACO in relation to urgent needs of regular flows of visitors in the historical centre and in its surrounding areas for the purposes of the general objective of protecting and enhancing the historical monuments, archaeological and landscape of the municipal territory emits the presence of Craco Card Gold and lays down the following conditions for the issue and its uses. The valid Craco Card Gold are those stamped and countersigned by the municipality of Craco:

L. The Craco Card Gold is an instrument for the creation of a national and international Community membership and voluntary support to the project of enhancement of the monumental and historical heritage, archaeological and landscape in the municipal territory. *"The Craco Card Gold has annual validity and its issued in respect of persons and subjects of legal personality. For residence of Craco, its extended to the entire nuclear family.*

2. It is issued to all either residents and/or non-residents wishing to make a suggestive visit in the secured pathway of the Museum Scenography Park of Craco, in places that are permitted and in compliance with the municipal ordinances.

3. The visit includes the areas of the historical centre kept in safety, the Media Centre, Atelier S. Lucy and the monastery of the Franciscans Minor Friars. Visit routes can be customized in case of groups of at least 5 persons. The Craco Gold Card entitles you to have an access and permanence in the areas and paths governed by the Trade Union Ordinance put in Max security for an hour. In these areas, there will be made available to the visitors a helmet of civil protection.

4. The Craco Card Gold entitles you to free access to all the existing cultural and artistic events and services provided at the monastery of the Franciscan Minor Friars and at the Media Centre.

5. At the media centre one is entitles to free access of internet and to the multimedia room in which you can view documents, archives of images and video on Craco.

6. It entitles the holder to make for a single day photographic and video for artistic and cultural purposes. Copy of artistic and cultural production made will be donated to the municipality of Craco to be preserved in the archives of multimedia productions and valued not for commercial purposes. For this specific task you will still need to submit advance authorization request to the technical office at the city hall which will establish the specific conditions from time to time,

7. Entitles you to free parking in parking areas allowed in the quarter of S. Angelo adjacent to the historic centre and in areas reserved to the holders of Craco Card.

8. Entitles you to receive a complimentary multimedia production CRACO PRODUCTION ON DVD created by the municipality of Craco and Craco Research Ltd. In alternative to multimedia production will be possible to obtain other products that the administration will make available. Through the web site of the Council will be possible to obtain a password to access some special content that will be made available online and benefit also from a reduction of 30% on all production Craco Production.

9. Entitles you to a discount of 50% on the tasting of typical products.

I O. The minimum size of donations for the release of Craco Card Gold is € 100,00.

1 1. Holders of Craco Card Gold undertake to respect all the rules and regulations in the use of computer and telematics services and relatively to the photographic and audio-visual its prohibited the use for commercial purposes of the same. Those who intend to shoot for professional activities must first be authorised by the municipal administration.
